Thank you for your interest in the U.S. Service Academies.

As your Representative in the 37th Congressional District of California, every year I have the privilege and responsibility of nominating talented young people to gain a top-quality college education and officer training at four of the five service academies:

Applying to a military academy includes all of the steps of applying to any other college, plus two extra elements: 1) gaining a nomination; and 2) demonstrating your physical fitness. YOU MUST open an application for admission to the academy as soon as possible, and meet the deadlines for submitting all pieces of your application to them. In addition, you must apply to my office for a nomination to the academy or academies where you hope to attend.

- American College Testing Program (ACT) results and/or College Board Scholastic Assessment Test (SAT) results*
- Resume of extracurricular activities**
- An essay stating why you want to attend a service academy (1-2 pages)**
- Minimum of three letters of recommendation**
