Reference: Southern California (SoCal) Metroplex Community Outreach – October November 2016

The Federal Aviation Administration (FAA) signed a Finding of No Significant Impact and (FONSI) Record of Decision (ROD) for the Southern California Metroplex project on August 31, 2016. This is the FAA’s final decision, and it enables the agency to move forward with implementing the project, which will replace dozens of existing conventional air traffic control procedures with new satellite-based procedures. The project encompasses most of Southern California and includes six major airports and 15 satellite airports. We undertook the project to improve airspace safety and efficiency by allowing for more optimized and efficient routing of aircraft into and out of Southern California.

I’m writing to let you know the FAA is planning community outreach in support of the implementation of the project. The outreach will consist of both public information briefings and internet-based webinars.

The project is being implemented in phases between November 2016 and April 2017. Please note that the outreach we are conducting this month will focus only changes that are occurring in November 2016.

We will conduct additional community outreach in early 2017 for the subsequent implementation phases of the project. We will notify you about those outreach opportunities in advance of the dates.
